

TOUR CONTRACT TODI 2025

This Tour Contract ("Contract") is entered into on _____, between AMERICA-ITALY SOCIETY OF PHILADELPHIA, hereinafter referred to as the "AIS," and

_____, hereinafter referred to as the "Client."

1. TOUR DETAILS

1.1 Tour Name: TODI 25

1.2 Tour Dates: June 15 to 21, 2025

1.3 Destination: TODI, Italy

1.4 Tour Plans:

- Plan A: accommodation with a host family (breakfast and dinner every day), classes and events
- Plan B: accommodation in a private apartment (meals not included), classes and events.
- Plan C: classes and events (accommodation not included)

2. PAYMENTS AND FEES (\$50 Off for members from Plan A, B, C and Payments in installments)

2.1 Total Tour Price: The Client agrees to pay the AIS the total tour price in ONE SOLUTION BY October 31, 2024, as outlined in the selected plan, as follows:

Plan A Price: \$1,930

Plan B Price: \$1,830

Plan C Price: \$1,350

2.2 Payment in 3 installments. The Client agrees to make payments as follows:

Plan A Price: \$2,050 (Oct. 31: \$650 – Feb. 28: \$700- April. 30: \$700)

Plan B Price: \$1,950 (Oct. 31: \$650 – Feb. 28: \$700- April. 30: \$600)

Plan C Price: \$1,470 (Oct. 31: \$650 – Feb. 28: \$700- April. 30: \$120)

2.3 Additional Costs: The Client shall be responsible for any additional costs not included in the selected plan, such as personal expenses, **travel insurance**, and optional activities.

3. CANCELLATION POLICY

3.1 Client Cancellation: In the event of the Client's cancellation, the following cancellation fees will apply:

A refund (\$100 will be withheld for office fees) will be issued only before February 1, 2025. For later dates only for medical emergencies

and only with a medical certificate, by April 15, 2024. No refund will be issued after April 15, 2024.
The America-Italy Society of

Philadelphia can make no land tour refunds for any reason whatsoever within 63 days of departure (April 15). Trip cancellation insurance is readily available and is highly recommended.

3.2 Tour Cancellation: The AIS reserves the right to cancel the tour due to unforeseen circumstances. In such cases, a full refund will be provided to the Client.

4. TOUR INCLUSIONS

4.1 Included Services: The tour package includes the services outlined in the selected plan, such as accommodation, meals, and guided tours.

4.2 Excluded Services: The tour package does not include services or items not specified in the selected plan.

5. CLIENT RESPONSIBILITIES

The Client is responsible for:

5.1 Travel Documents: Obtaining all necessary travel documents, including a valid passport and any required visas.

5.2 Health and Insurance: Obtaining adequate travel insurance **and ensuring good health for travel.**

5.3 Behavior: Behaving responsibly and respectfully towards fellow travelers, tour staff, and local communities.

6. LIMITATION OF LIABILITY

The AIS shall not be held liable for:

6.1 Force Majeure: Any losses, delays, or changes in the tour itinerary due to unforeseeable circumstances beyond the control of the AIS.

6.2 Personal Property: Loss or damage to personal property during the tour.

6.3 The tour member understands that he or she has no claim against the America-Italy Society of Philadelphia for any delay or damage to or loss of property or baggage or injury to or death of person due to any negligent or willful act of a direct air carrier, hotel, ground transportation company, cruise company, railroad, or service company of any kind in Europe. You may see the name the "America-Italy Society of Philadelphia" affixed to motor vehicles, on signs around the airport, hotel or elsewhere. This use of our name is purely for reasons of identification and does not denote ownership, supervision, or control by the America-Italy Society of Philadelphia in any way.

Please purchase the insurance coverage you require before, during and for your return from vacation.

6.4 POST-TOUR CLAIMS: You understand and agree that no claims will be considered and that you will not sue the America-Italy Society of Philadelphia unless you have first provided a written notice

of claim to the America-Italy Society of Philadelphia within 30 days after the tour or the cancellation of the tour.

7. GOVERNING LAW

This Contract shall be governed by and construed in accordance with the laws of Pennsylvania.

8. ACCEPTANCE
